Résumé général de l'activité

The company is a factory with a monthly maximum capacity of 1.4 million m² of geotextile or 6.5 million yellow cleaning cloths.

The company is currently the only manufacturer of yellow cleaning cloths in Romania and has contracts with Romanian market leaders for this product. Additionally, the factory has secured contracts with Ukraine and Germany for its products. Bioretex Romania has a significant opportunity to expand and is looking to a buyer for €1.5 million.

Located in Constanța County, the factory is near the Romania's largest port on the Black Sea, allowing for easy transportation and import/export. Bioretex Romania can produce EU goods from non-EU materials through legal nationalization processes.

Moreover, the factory has secured rights and authorizations from the Romanian Ministry of Environment for recycling textile fabrics. The factory's products are CE certified, and it has an integrated management system according to ISO 9001:2015, ISO 14001:2015, ISO 45001:2018.

The factory's production facility spans 7,500m² with the possibility of expanding its production area by constructing new halls. It has a maximum of 400 kW electricity supply, created by accessing European funds with the opportunity to obtain other investment funds. The location of the factory is ideal for production expansion as Romania and Ukraine have over 8 billion € invested in road development.

The company's main stock consists of green and yellow viscose fibers, melange, black, yellow, and white polyester fibers, and white and colored polypropylene fibers. The factory also has a second storage of raw material consisting of fabric wastes and recycled fibers from fabric wastes to be reused.

The company's products include

Bioretex geotextiles (PES+PP) for the construction sector,
Bio Grass Green (Viscose+Grass+Fertilizer) for landscaping,
Universal Cleaning cloth (Viscose+PES) for cleaning,
Protex anti-slip (Recycled textile fibers+LDPE foil) for protection,
Geogarden (PES) for agriculture,
And Tex Carpet, Backing, and Automotive for other uses.

The factory has major machines purchased using European funds, and improvements to increase performance and operability have led to new acquisitions. All machines are operated from control panels, and settings can be modified depending on the used fibers and the required products.

Indications concernant les éléments chiffrés

Last year (2023) turnover is 500kEur with a net profit margin of 21% using less than half capacity of the factory.

The machines are listed in detail below.

Positionnement concurrence

Positionnement par rapport au marché

The company holds CE and ISO certifications, among other relevant documents.

We have the right to produce geotextiles, approved by the Ministry of Public Works, making us one of only two firms accepted for Romanian state tenders.

We also hold a license from the Ministry of Environment to recycle 10,000 tons of textiles. As the 2025-2030 transition towards textile recycling progresses, these pre-allocated quotas are expected to increase in value.

Additionally, we already produce (cleaning clothes) jumbo rolls for packaging and distribution companies in Romania and Ukraine.

Points forts

The company offers potential buyers a unique opportunity to expand their business. The factory owner is looking to sell for €1.5 million, but the annual production capacity could reach up to €5.5 million with full capacity utilization. The owner is willing to continue working with the new owner in a capacity to set up procurement and sales teams. Buyers in Romania can take advantage of a monthly installment plan of €30K for five years, secured through a leasing firm.

The factory is situated in a prime location that offers room for expansion. It boasts double lines of cutting-edge machinery, and the company has secured rolling contracts. The production and office staff are currently operating to ensure smooth and efficient operations.
